

Fairytales and Dragon Scales 2025 Coloring Contest Rules

Contest Rules: No purchase necessary to enter or win. Void where prohibited. A purchase does not increase your chances of winning. To enter, print out or pick up the Fairytales and Dragon Scales 2025 Coloring Contest Coloring Sheet and entry form. Coloring should be the work of a person the age of 0-17 for the child contest or 18 and older for the Adult contest. An adult may not help on the child contest entries. Use only crayons, markers or colored pencils on the specific Fairytales and Dragon Scales 2025 Coloring Contest Coloring Sheet. No digital art entries. Please send in the Contest Entry Form attached to the Fairytales and Dragon Scales 2025 Coloring Contest Coloring Sheet. Entries with incomplete entry forms or submitted without an entry form will not be accepted. There will be two age divisions: 0-17 year olds and older than 18 years old.

Eligibility: Fairytales and Dragon Scales 2025 Coloring Contest Coloring Sheet ("Contest") is open to legal residents of The United States. Employees of Fairytales and Dragon Scales ("Sponsor") and their immediate families are not eligible to participate in the contest. Contest is subject to all applicable federal, state, local laws and regulations and is void where prohibited by law. The Contest has two age specifications and the contestant must enter in their correct age range. Fairytales and dragon Scales will not and is not responsible for moving the entry to the correct age specification. Contest begins October 31st, 2025 and ends on December 31st 2025 at 5:00pm CST. Entries must be received by 5:00pm CST on December 31st 2025 to be eligible.

How to Enter: Pick up a coloring contest sheet and entry form from a Fairytales and Dragon Scales Booth location or download online at www.fairyanddragon.com

The entry form must include your name, phone number or email address and parent or legal guardian's name. Only one (1) entry per individual during the Contest period is allowed; subsequent entries from the same individual will be disqualified. Entries become the property of Sponsor and will not be acknowledged or returned. Selection of Prize Winner: One winner will be chosen for each of the two age categories (ages 0-17; ages 18 and up). Odds of winning depend on number of eligible entries received. Unless otherwise prohibited, prize winners will be required to sign and return an Affidavit of Eligibility and Liability/Public Release within five (5) calendar days of notification attempt, or prize will be forfeited and an alternate winner will be selected. Forfeited prize will be awarded to the next runner up.

Prizes: 1 prize per age division: 1 Legendary Dragon Egg made as close to their design as artistically possible by our artist. The egg will have the dragon selected on the coloring sheet inside to be hatched by the winner. The prizes are non-transferable and may not be redeemed for cash value or exchanged for any other prize. Sponsor reserves the right to substitute a prize of equal or greater value in its sole discretion.

Miscellaneous: No facsimiles or mechanical reproductions of entry forms will be accepted. Entry forms that have been tampered with or altered are void. Entrants found tampering with or abusing any aspect of the Contest, as solely determined by the Administrator, will be disqualified. Any attempt by any person to deliberately undermine the legitimate operation of the Contest may be in violation of criminal and civil law and should an attempt be made, Sponsor reserves the right to seek damages from any such person to the fullest extent of the law. Sponsors' failure to enforce any term of these Official Rules shall not constitute a waiver of that provision. Sponsor reserves the right to terminate, cancel, suspend, and/or

modify the Contest if any fraud, virus, or other problem corrupts the administration, security, or proper play of the Contest, as determined by Sponsor in its sole discretion. In such an event, Sponsor reserves the right to award the prizes at random from among the non-suspect entries received up to the time of impairment. If any such malfunction, error, disruption or similar damage occurs and impairs the administration, security, fairness, integrity or proper play of the Contest, Sponsor may, in its sole discretion, suspend or terminate the Contest by posting a notice on www.fairyanddragon.com. Sponsor and Administrators are not responsible for lost, late, misdirected, illegible and damaged entries. The Administrator will be the sole judge of which entries are valid and its decision is final and binding. Entering the Contest and accepting the Prize constitutes permission to use the name and likeness of the prize winner for advertising and publicity purposes without further compensation, unless prohibited by law.

Submitted designs become the property of Sponsor, and entrants lose all rights to the designs. Entrants will not be compensated for their designs that may be used, in part or full, of any future egg designs produced by Sponsor.
